- 1 Be it enacted by the Senate and House of Representa-

- 4 This Act may be cited as the "Transparency in Re-
- 5 covery Assistance and Claims Knowledge Act" or the
- 6 "TRACK Act".

2	Section 430(a) of the Robert T. Stafford Disaster Re-
3	lief and Emergency Assistance Act (42 U.S.C. 5189h(a))

1	"(i) The damage category code.
2	"(ii) For each proposed grant award,
3	information on each cost estimate, appli-
4	cant ID, the date of each submission, the
5	descriptions for each project, and the cost
6	of each project with a breakdown of the
7	Federal cost-share and non-Federal cost-
8	share.
9	"(iii) Status of the Agency review and
10	approval of each cost estimate submitted,
11	including the date on which a project is
12	approved and the date on which the grant
13	is issued.
14	"(iv) An explanation for any cost esti-
15	mate that is not approved, or if the grant
16	is not provided in the timeline as required,
17	and any corrective action taken by the
18	Agency.
19	"(v) Project-level progress updates.
20	"(vi) Information on requests for as-
21	sistance made, including dates and
22	amounts of each request, timelines for sub-
23	missions of required information, and
24	dates of approval and disbursement of
25	awards.

1	"(vii) Any other information the Ad-
2	ministrator determines to be appropriate to
3	ensure transparency and accountability in
4	the administration of public assistance.".
